-  **GAVIN WILKINSON REMOVED FROM PTFC ORGANIZATION**
WAS REMOVED AS THORNS GM. MANAGEMENT STRUCTURE AND LEVEL OF INVOLVEMENT IN THORNS ORGANIZATION IS UNCLEAR. HOWEVER, CONTINUES TO BE INVOLVED WITH TIMBERS/ACADEMY.
-  **IMPLEMENT A TRANSPARENT AND PROACTIVE SAFETY, TRAINING, AND ACCOUNTABILITY PLAN THAT IS APPROVED BY THE PLAYERS**
DISCRIMINATION EDUCATION TRAINING HAS BEGUN FOR STAFF; SAFESPORT TRAINING, AND ANONYMOUS INTERNAL REPORTING SYSTEM. UNCLEAR IF TRAININGS WERE APPROVED BY PLAYERS
-  **CREATE AN EXECUTIVE-LEVEL DIVERSITY OFFICER POSITION**
HAS BEGUN INTERVIEWING FOR VP OF COMMUNITY AND SOCIAL IMPACT; DIVERSITY, EQUITY, AND INCLUSION. PROCESS SHOULD BE COMPLETE JULY
-  **DEMONSTRATE TRANSPARENCY THAT PLAYERS' VOICES WILL BE PROMINENT IN THE HIRING OF THE NEXT THORNS COACH/GM**
EXPANDED BACKGROUND CHECKS AND PLAYERS INPUT FOR LATEST GM
-  **HIRE SEPARATE GENERAL MANAGERS FOR THORNS & TIMBERS**
-  **CREATE A CLUB CULTURE AND PLAYER LIAISON POSITION FOR EACH TEAM WHOSE SOLE PURPOSE IS TO MENTOR AND SUPPORT PLAYERS.**
PLAYER INPUT WAS GIVEN, BUT DOES NOT APPEAR THEY CREATED A POSITION, ONLY NEW PATHWAYS/PROCESSES
-  **DISCLOSE WHO HAS BEEN SECURED TO COMPLETE THE NEW INVESTIGATION OF THE 2015 EVENTS AND SUBSEQUENT INVESTIGATION.**
